CONGRESSIONAL MONITOR

THE 109TH CONGRESS: JANUARY 2005-JANUARY 2007

With this issue, JPS inaugurates a new section that will monitor U.S. congressional initiatives dealing with Palestine and Israel. Substantively, the initiatives—listed chronologically—include all relevant acts, bills, appropriations, and resolutions (joint, concurrent, and simple) that mention, even briefly, either Palestine or Israel. Speeches are not included. Space considerations have prevented more than a very brief description of each initiative, along with essential details such as bill number, date introduced, name of sponsor and number of cosponsors, votes cast, last action taken, and companion measures. The format is designed to give the reader an overview of legislation that relates to the Palestine issue and to help identify the major themes of legislation, its initiators, their priorities, the range of their concerns, and their attitudes toward the regional actors. While this first monitor covers two years—both annual sessions of the 109th Congress—each new Congress will be treated by annual session. Material in this compilation is drawn from thomas.loc.gov.

This is part of a larger IPS project to cover the current 110th Congress, subsequent congresses, and previous congresses dating back to the start of the second Bush administration and beyond, while simultaneously monitoring ongoing and past executive policy statements on the same topics. The expectation is that cumulative congressional data, when compared and/or contrasted to parallel executive data, could generate new insights into the process of and the influences upon U.S. foreign policymaking with respect to one of the most central and volatile conflicts of modern times.

THE 109TH CONGRESS

Throughout the two years that the 109th Congress was in session—from 3 January 2005 to 3 January 2007—Republicans controlled both the Senate and the House of Representatives; the Democratic majority elected to both chambers in the November 2006 elections was not sworn in until the opening of the 110th Congress in January 2007.

Several landmark events in Israel and the occupied Palestinian territories occurred during the two-year period under review. As the 109th Congress opened in January 2005, Mahmud Abbas was elected president of the Palestinian Authority (PA), succeeding Yasir Arafat, who had died in November 2004. A year later, coinciding with the opening of the second session of the 109th Congress, Israeli prime minister Ariel Sharon suffered a stroke and fell into a coma, removing him from public life; Ehud Olmert, who immediately assumed control, was formally elected prime minister in March 2006. Meanwhile, Hamas, which had chalked up victories throughout municipal elections in Gaza and the

West Bank in the second half of 2005, unexpectedly won the Palestinian parliamentary elections on 25 January 2006, ending Fatah's control of the PA and its unquestioned 40year dominance of the Palestinian national movement. The year also saw Israel's devastating summer war on Lebanon and growing U.S.-Israeli concerns over Iran. Many of these events are referenced in the congressional initiatives. Sharon's passage from the scene was marked by a tribute to the Israeli Arab nurse who treated him at Hadassah hospital in a House speech on 16 July 2006. Reflecting events on the ground more generally, there was a marked upsurge in anti-PA initiatives following the formation of the Hamas government in March 2006, though it should be noted that efforts to block aid to the PA preceded this event by eleven months: On 8 March 2005, when Abbas and Fatah were still firmly in control, the House introduced a bill calling for the prohibition of U.S. aid to the PA and of programs in the territories unless, inter alia, there was an "absence of violence" there. Immediately following the Hamas electoral victory, the Palestinian Anti-Terrorism Act (PATA; see excerpts in Doc.

D3 in *JPS* 143) was introduced (1 February 2006 in the House; 6 March 2006 in the Senate), which required, among other things, that PA territory be designated a "terrorist sanctuary" unless Hamas adhered to nine conditions (see PATA 3/6/06).

Overall, however, one is struck by a certain disconnect between specific events on the ground and the concerns of Congress, with large numbers of initiatives taken up with such items as commemorating Israeli anniversaries, intervening on Israel's behalf with various non-U.S. bodies (e.g., United Nations, NATO, International Committee of the Red Cross, Organization of Economic Cooperation and Development), supporting Jerusalem as Israel's capital, and promoting Holocaust awareness.

FIRST SESSION (2005)

6 January 2005: Support for Israel joining the Organization of Economic Cooperation and Development (OECD)

H. Res. 38, Ileana Ros-Lehtinen (R-FL), 41 cosponsors at time of passage.

Last major action: 11/8/05 passed in House 391-0.

26 January 2005: Urging UN to address anti-Semitism in the United Nations

H. Res. 54, Ileana Ros-Lehtinen (R-FL), 32 cosponsors as of 4/19/05.

Calls on UNESCO to develop and implement Holocaust education globally; calls on U.S. president to direct UN representative to work toward reducing anti-Semitic language and anti-Israel resolutions in UN; calls on the U.S. secy. of state to include in the annual Country Reports on Human Rights Practices a section on compliance by the UN and its constituent bodies with international human rights treaties and norms related to anti-Semitism and to expend funds to es-

tablish education programs for Arabs and Muslims on the issue.

Related measures: H. Res. 282 of 5/17/05; S. Res. 184 6/29/05; S. Res. 240 on 9/15/05.

Last major action: 3/17/05 referred to committee.

1 February 2005: Praising PA presidential elections won by Mahmud Abbas

H. Res. 56, Roy Blunt (R-MO), 3 cosponsors.

Related measures: S. Res. 27 2/1/05. Last major action: 2/2/05 passed in House 415-1.

1 February 2005: Praising PA presidential elections, recognizing victory of Mahmud Abbas

S. Res. 27, Bill Frist (R-TN), 8 cosponsors. Also commends Israel for facilitating the elections and calls on Arab governments to recognize Israel.

Related measures: H. Res. 56 2/1/05. Last major action: 2/1/05 passed in Senate by unanimous consent.

2 February 2005: Supporting Jerusalem as the capital of Israel

H. R. 588, Thomas Reynolds (R-NY), 42 cosponsors as of 9/8/05.

Calls for cutting back services of U.S. consulate in Jerusalem, referring to Jerusalem as the capital of Israel in all official documents, and listing "Israel" as the birthplace of those born in Jerusalem.

Last major action: 3/17/05 referred to subcommittee.

15 February 2005: Encouraging EU to put Hizballah on its list of terrorist organizations

H. Res. 101, James Saxton (R-NJ), 75 cosponsors at time of passage.

Also calls for Hizballah to stop supporting "Palestinian terrorist organizations" such as al-Aqsa Martyrs Brigade, Popular Front for the Liberation of Palestine, Islamic Jihad, and Hamas; and for the dismantlement of Hizballah according to UNSC Res. 1559.

Related measures: S. Res. 82 3/15/05. Last major action: 3/14/05 passed in House 380-3, 5 present.

8 March 2005: Prohibiting [U.S.] aid to the PA in the West Bank and Gaza until certain conditions are met

H. R. 1143, Anthony Weiner (D-NY), 9 cosponsors as of 2/7/06.

Conditions cited include that the PA be untainted by violence; that terrorist

infrastructure be dismantled; that there be no violence in the West Bank or the Gaza Strip; and that the PA publicly rebuke terrorism.

Last major action: 3/17/05 referred to subcommittee.

10 March 2005: Recognizing the expansion of Israel's national museum, Yad Vashem

S. Res. 79, Jon Corzine (D-NJ), 1 original cosponsor.

"Expressing the sense of the Senate in marking the dedication on 15 March 2005 of the expanded museum complex at Yad Vashem."

Last major action: 3/10/05 passed in Senate by unanimous consent.

11 March 2005: Emergency Supplemental Appropriations, FY2005

H. R. 1268, Jerry Lewis (R-CA), no cosponsors.

Provides \$200 m. to support the Palestinians, of which \$50 m. is for assistance to Israel "to help ease the movement of Palestinian people and goods in and out of Israel" and \$5 m. is for an outside, independent audit of PA expenditures to determine the extent of transparency and accountability in PA finances, leaving \$145 m. for Palestinians.

Last major action: 5/11/05 became Public Law No. 109-13.

15 March 2005: Urging EU to put Hizballah on list of terror organizations

S. Res. 82, George Allen (R-VA), 15 cosponsors at time of passage.

Related measures: H. Res. 101 2/15/05. Last major action: 4/29/05 passed in Senate by unanimous consent.

17 March 2005: Designating week of 1 May 2005 as Holocaust Awareness Week

S. Res. 90, Richard Lugar (R-IN), 3 original cosponsors.

Last major action: 3/17/05 passed in Senate by unanimous consent.

14 April 2005: Moving the U.S. embassy to Jerusalem 180 days prior to recognizing a Palestinian state

S./H.J. Res. 14, Samuel Brownback (R-KS), 5 cosponsors as of 9/11/06.

"The United States shall not recognize a Palestinian state until the international community resolves the status of Jerusalem by recognizing the city as the undivided capital of Israel."

Last major action: 4/19/05 referred to committee.

28 April 2005: Outlawing PLO offices in the U.S.

H. R. 2036, Anthony Weiner (D-NY), 3 cosponsors as of 5/23/05.

Aims to downgrade PLO or PA office in the U.S. to the status of information office, as existed prior to the Oslo Accord.

Last major action: 5/17/05 referred to subcommittee.

4 May 2005: Condemning attacks on U.S. citizens by Palestinian terrorists

H. Con. Res. 144, Steve King (R-IA), 72 cosponsors as of 9/21/05.

Last major action: 5/17/05 referred to subcommittee.

5 May 2005: Conferring honorary U.S. citizenship on Anne Frank

S./H.J. Res. 48, Steve Israel (D-NY), 30 original cosponsors.

Grants Anne Frank honorary citizenship and recognizes her as an "inspiration, and an example for all, especially for the young people of this Nation."

Last major action: 6/6/05 referred to subcommittee.

11 May 2005: Congratulating Israel on the 57th anniversary of its independence, 2005

H. Con. Res. 149, Addison Wilson (R-SC), 78 cosponsors as of 5/19/05.

Related measures: S. Res. 151 on 5/19/05; H. Con. Res. 392 on 4/26/06.

Last major action: 5/23/05 passed in House 397-0; 5/24/05 referred to Senate committee.

16 May 2005: Condemning British Association of University Teachers (BAUT) resolution to boycott Bar-Ilan University and Haifa University

H. Res. 279, Brian Higgins (D-NY), 42 cosponsors as of 6/7/05.

Also calls on BAUT to overturn its 4/22/05 vote at its hearing on 5/26/05. Denounces the association's demand that professors from these two Israeli universities take oaths disavowing the Israeli government.

Last major action: 5/19/05 referred to subcommittee.

17 May 2005: Encouraging UN to address anti-Semitism

H. Res. 282, Ileana Ros-Lehtinen (R-FL), 32 cosponsors.

Related measures: **H. Res. 54 on 1/26/05**; S. Res. 184 6/29/05; S. Res. 240 on 9/15/05.

Last major action: 6/7/05 passed in House 409-2.

19 May 2005: Praising Israel and all its global contributions on the occasion of its 57th independence, 2005

S. Res. 151, Bill Frist (R-TN), 6 original cosponsors.

Related measures: H. Con. Res. 149 on 5/11/05

Last major action: 5/19/05 passed in Senate by unanimous consent.

26 May 2005: U.S-Israel Energy Cooperation Act

H. R. 2730, John Shadegg (R-AZ), 100 cosponsors as of 6/22/06.

Directs the secv. of energy, in consultation with the U.S.-Israel Binational Industrial Research and Development Foundation or the U.S. Binational Science Foundation, to establish a grant program for joint ventures, composed of both Israeli and U.S. private business entities or of U.S. and Israeli academics, to implement projects to encourage cooperation between the U.S. and Israel on research, development, or commercialization of alternative energy, improved energy efficiency, or renewable energy sources. It also establishes within the Dept. of Energy an International Energy Advisory Board to advise the secretary on the grant program and grant recipients and appropriates \$20 m. each year from 2006 to 2012.

Last major action: 7/26/06 passed in House by voice vote and 7/27/06 referred to Senate committee.

7 June 2005: Henry J. Hyde UN Reform Act of 2005, reduce funds to UN-RWA, grant Israel membership in UN grouping

H. R. 2745, Henry Hyde (R-IL), 1 cosponsor.

Demands that the U.S. contribution to the United Nations Relief and Works Agency for Palestine Refugees (UNRWA) not exceed either the highest contribution to UNRWA by an Arab country or 22 percent of UNRWA's total budget; calls on U.S. to use its influence with the UN to secure Israel's full permanent membership in the UN Western European and Others Group (WEOG); calls for a U.S. audit and report on duplicative entities and functions of: (1) the UN Division

for Palestinian Rights; (2) the Committee on the Exercise of the Inalienable Rights of the Palestinian People; (3) the UN Special Coordinator for the Middle East Peace Process and Personal Representative to the PLO and PA; (4) the NGO Network on the Question of Palestine: (5) the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Palestinian People and Other Arabs of the occupied territories.: and (6) any other entity the secy. of state determines results in "duplicative efforts or funding or fails to ensure balance in the approach to Israeli-Palestinian issues." The Hyde legislation also urges "the shifting of 18 programs from regular assessed budget authority to voluntary funded programs."

10 June 2005: Appropriations FY2006, Commerce, Justice, Science, State

H. R. 2862, Frank Wolf (R-VA), no cosponsors.

The State Dept. portion of the bill appropriates \$375,000 for the Israeli-Arab Scholarship program for Israeli Arabs to attend institutions of higher education in the United States; bars U.S. assistance to the Palestinian Broadcasting Corporation; requires the secy. of state, for purposes of registration of birth, certification of nationality, or issuance of a passport of a U.S. citizen born in Jerusalem, to record the place of birth as Israel upon request of the citizen.

Last major action: 11/22/05 became Public Law No. 109-108.

10 June 2005: Appropriations FY2006, Dept. of Defense

H. R. 2863, Bill Young (R-FL), no cosponsors.

Provides \$132.866 m. for research, development, and evaluation of the Arrow missile defense program of which \$60.25 m. must be used for production of missile components in Israel and the U.S.; \$10 m. will be spent on a joint feasibility study on developing a Short Range Ballistic Missile Defense program.

Related measures: H. R. 5631 on 6/16/06 for defense appropriations FY2007.

Last major action: 12/30/05 became Public Law No. 109-148.

24 June 2005: Appropriations FY2006, Dept. of State and Foreign Operations

H. R. 3057, Jim Kolbe (R-AZ), no cosponsors.

Total aid to Israel appropriated is \$2.56 b. This breaks down into: \$2.28 b. in Foreign Military Financing, which is available for purchase of advanced weapons systems, and of which \$595 m. may be used for procurement, research, and development in Israel; \$240 m. in Economic Support Funds as cash transfer in full and in 30 days; \$40 m. for Migration and Refugee Assistance to assist the resettlement of Eastern European and Russian immigrants into Israel.

The bill also conditions its voluntary contribution (at least \$50 m.) to the International Atomic Energy Agency (IAEA) and the Comprehensive Nuclear Test Ban Treaty Preparatory Commission on Israel's free access to the IAEA; conditions funding (approximately \$12.5 m.) for the International Committee of the Red Cross (ICRC) headquarters account on the Israeli Magen David Adom Society's free access to the ICRC; provides for commercial leasing of military equipment to Israel (among others) and includes Israel (among others) in the category of NATO for purposes of the Arms Export Control Act of 1976; urges the U.S. to consider the Arab boycott of Israel when making decisions on weapons sales to any country participating in the boycott; and provides \$150 m. in Economic Support Funds for USAID projects in the West Bank and Gaza Strip.

The bill specifically prohibits: funds for the PLO in the West Bank and Gaza Strip without a national security waiver from the president; funds to build any new U.S. department or agency in Jerusalem that will deal with the PA; and funds to support a Palestinian state unless the PA government is democratically elected, dismantles terrorist infrastructure, cooperates with Israel on security matters, and promotes peaceful coexistence with Israel. It also prohibits funds to the Palestinian Broadcasting Corporation.

29 June 2005: Addressing anti-Semitism expressed by UN member states

S. Res. 184, Richard Santorum (R-PA), 16 cosponsors as of 9/27/05.

Last major action: 6/29/05 referred to committee

13 July 2005: United Nations Reform Act, reducing funds to UNRWA, granting Israel membership in UN grouping

S. 1394, Gordon Smith (R-OR), 5 cosponsors as of 11/8/05.

Related measures: **H. R.** 2745 of 6/7/05. *Last major action:* 7/14/05 placed on Senate legislative calendar.

19 July 2005: Congratulating Israel on the election of its UN Ambassador Dan Gillerman as Vice-President of the 60th United Nations General Assembly

H. Res. 368, Adam Schiff (D-CA), 80 cosponsors at time of passage.

Notes that Israel, until 2000 the only country in the UN General Assembly lacking a regional grouping designation, was nominated in 2005 by Western European countries for inclusion in the WEOG and was elected vice-president of the 60th annual General Assembly with Dan Gillerman approved as the permanent Israeli representative to the UN.

Last major action: 10/27/05 passed 407-

15 September 2005: Encouraging UN to address anti-Semitism

S. Res. 240, Richard Santorum (R-PA), 17 cosponsors at time of passage.

Related measures: H. Res. 54 on 1/26/05; H. Res. 282 on 5/17/05; S. Res. 184 on 6/29/05.

Last major action: 9/15/05 passed in Senate by unanimous consent.

15 September 2005: Recognizing the suffering of both Palestinians and Israelis during Gaza disengagement

H. Res. 448, Michael Capuano (D-MA), no cosponsors.

"Recognizing the suffering of both Israelis and Palestinians and acknowledging the sacrifices made in the interest of peace by the Israeli settlers who left the Gaza Strip voluntarily, and for other purposes."

Last major action: 9/15/05 referred to committee.

7 October 2005: U.S.-Israel Energy Cooperation Act

S. 1862, Gordon Smith (R-OR), 15 cosponsors as of 7/12/06.

Instructs the secy. of energy, in implementing the Agreement between the Dept. of Energy of the United States of America and the Ministry of Energy and Infrastructure of Israel Concerning Energy Cooperation, to establish a grant program to support research, development, and commercialization of alternative renewable energy sources

Authorizes \$20 m. annually from 2006 to 2012 for grants to promote the following: (1) solar energy; (2) biomass energy; (3) energy efficiency; (4) wind energy; and (5) fossil energy. Also directs the secretary to establish an advisory board to: (1) monitor how such grants are awarded; and (2) provide periodic performance reviews of actions taken to carry out the grant program.

Last major action: 10/7/05 referred to committee.

27 October 2005: Condemning Iranian President Mahmoud Ahmadinejad's words about "wiping Israel from the map"

S. Res. 292, Frank Lautenberg (D-NJ), 15 cosponsors as of 11/1/05.

Related measures: H. Res 523 on 10/28/05; H. Res. 601 on 12/14/05; H. Res. 611 on 12/15/05; S. Res. 336 on 12/16/05; S. Res. 337 on 12/16/05.

Last major action: 10/27/05 passed in Senate by unanimous consent.

28 October 2005: Condemning Iranian President Ahmadinejad's threats against Israel

H. Res. 523, Henry Hyde (R-IL), 69 original cosponsors.

Also calls on the UN to consider measures to stop Iran from carrying out such threats; affirms the U.S-Israel relationship.

Related measures: S. Res. 292 on 10/27/05; H. Res. 601 on 12/14/05; H. Res. 611 on 12/15/05; S. Res. 336 on 12/16/05; S. Res. 337 on 12/16/05.

Last major action: 10/28/05 passed in House 383-0, 1 present.

4 November 2005: Honoring Yitzhak Rabin 10 years after his death

H. Res. 535, Eliot Engel (D-NY), 44 cosponsors as of 12/6/05.

Commemorates the 10th anniversary of the death of former Israeli PM Rabin, states with admiration his role in the Palmach (the strike force of the Jewish paramilitary Haganah during the British Mandate); and affirms support for his historical role and vision in service to the Israeli people. Also praises U.S.-Israeli relations, "condemns any and all acts of terrorism," and affirms that "democratic leaders and governments must be changed only by the democratically expressed will of the people."

Last major action: 12/6/05 passed in House 399-0.

10 November 2005: Honoring Yitzhak Rabin 10 years after his death

S. Res. 310, Frank Lautenberg (D-NJ), 5 original cosponsors.

Last major action: 11/10/05 passed in Senate by unanimous consent.

18 November 2005: Forbidding Hamas to participate in Palestinian elections

H. Res. 575, Eric Cantor (R-VA), 163 cosponsors as of 12/15/05.

Last major action: 12/16/05 passed in House 397-17, 7 present.

14 December 2005: Condemning Iranian President Ahmadinejad's rhetoric toward Israel

H. Res. 601, Tom Cole (R-OK), 70 cosponsors as of 3/1/06.

Condemns the President's "vile assertions" about Israel, calls for world censure of Iran and on the UN to stop Iran's nuclear arms acquisition, and affirms that "the millions murdered in the Holocaust must never be forgotten and such atrocities should never happen again."

H. Res. 611, Charles Dent (R-PA), no cosponsors.

Last major action: 12/15/05 referred to committee.

16 December 2005: Simon Wiesenthal Holocaust Education Assistance Act of 2006

H. R. 4604, Carolyn Maloney (D-NY), 24 cosponsors as of 9/6/06.

Seeks to provide \$2 m. annually for five years to 501(c)(3) organizations to teach about the Holocaust or conduct activities that promote awareness of it.

Related measures: companion measure S. 2651 on 4/25/06.

Last major action: 3/27/06 referred to subcommittee.

16 December 2005: Condemning the "harmful, destructive and anti-Semitic statements" of Iranian President Ahmadinejad

S. Res. 336, Richard Santorum (R-PA), 21 original cosponsors.

Related measures: S. Res. 292 on 10/27/05; H. Res 523 on 10/28/05; H. Res. 601 on 12/14/05; H. Res. 611 on 12/15/05; S. Res. 337 on 12/16/05.

unless the president determines it is within the national security interests of the U.S. Finally, the bill establishes a fund called the "Israeli-Palestinian Peace, Reconciliation and Democracy Fund" with an annual budget of \$20 m. to be made available to Palestinian and Israeli organizations to promote human rights, democracy, freedom of the press, nonviolence among Palestinians, and peaceful coexistence between Palestinians and Israelis.
